WHEREAS the AMPA Regulations were amended on March 31, 2026 to increase the interest free benefit for all 2026 advances from \$100,000 to \$250,000; and

WHEREAS advances issued at the above limit are contingent on the amended 2026 Advance Guarantee Agreement between the Minister, the Administrator and the Lender being in place.

WHEREAS advances issued at the above limit are contingent on the amended 2026 Advance Guarantee Agreement to Pay Interest between the Minister and the Administrator being in place.

THEREFORE in respect of an advance made to the producer by the Administrator for the 2026 Program Year, and AMPA Regulations subsequently being amended, the parties hereby agree as follows:

- The Government of Canada will pay the interest on the first \$100,000 in advances and effective March 31, 2026, the Government of Canada will pay the interest on an additional \$150,000 in advances.

PRODUCER DECLARATION
